## PRIVACY POLICY

GATHR, S.L.U., is the controller of personal data provided by its users.

The processing of personal data carried out through the platform complies with the provisions of Regulation (EU) 2016/679, General Data Protection, in Organic Law 3/2018, of 5 December, on the Protection of Personal Data and with the appropriate technical and organisational security measures to guarantee a level of security appropriate to the risk of the processing.

### 1. Data protection information

If the user registers, the data strictly necessary to achieve the purpose for which our community is intended will be requested, which is the information, execution and promotion of our services, all of which are available on the platform. In no case will they be used for purposes other than those for which they have been voluntarily introduced.

Those who voluntarily provide their data to the owner by any of the means established for this purpose at any time, have had at their disposal in a transparent and clear manner, by clicking on the corresponding box, the following information on data protection:

1.2 The **PURPOSES of the processing** are the following:

Main purposes:

- Management of user records and administration of community accounts (registration, access, profile maintenance, security and support).
- Provision of the online community service about life in Spain: publication and visualization of content, interaction between members (posts, comments, messages), dissemination of events. Manage members, publish posts, host events, host discussions, send messages and emails to members, and manage subscriptions and community engagement.
- Community moderation and enforcement (detection and management of content or behavior contrary to the rules, blocking or suspension of accounts where appropriate).
- Management of communications related to the service (notices of changes in conditions, technical incidents, security, relevant news of the operation of the community).

Additional purposes (if applicable):

- Sending informative or newsletter-type communications about the community, content and events (if done, based on legitimate interest or consent, depending on the approach you choose).
- Internal statistics and improvement of the service (analysis of use, usability, most consulted content), with aggregated or pseudonymised data whenever possible.

### 1.3 LEGAL BASIS

- Execution of the contract (art. 6.1.b GDPR): management of the registry, access to the community, use of basic functionalities, moderation necessary for the correct provision of the service.
- Compliance with legal obligations (art. 6.1.c GDPR): compliance with consumer and user regulations, LSSI, minimum accounting/tax obligations associated with the service, attention to data protection rights.

- Legitimate interest of the controller (art. 6.1.f GDPR): security of the Platform, prevention of abuse or fraud, temporary retention of certain logs to defend against possible claims, internal statistics of use to improve the service, always weighed against the rights of the users.
- Consent (art. 6.1.a GDPR): only when purposes that are not necessary for the basic service are enabled, such as certain commercial communications or newsletters not strictly linked to the functioning of the community, or the use of non-technical cookies, if applicable.

#### **1.4 RETENTION PERIOD**

## **2. Information about users**

We do register your IP (Internet Protocol) data assigned to the subscriber who owns the telephone line at the time of connection, for the purpose of security and collaboration with the Justice. The data will be kept by the service provider for the time set by current legislation.
